## **Course Description:**

Police authority, responsibilities, constitutional restraints, laws of arrest, search and seizure, and police liability.

### Student learning outcome:

At the conclusion of this course, students will be able to:

- 1. List and explain the legal arrest authorities in Texas.
- 2. Define frisk and apply the concepts in mock situations.
- 3. Define temporary detention and give situations where its application would be applicable.
- 4. Explain the constitutional restraints on police regarding arrest, search and seizure.
- 5. Explain police liability.
- 6. Explain the landmark cases listed: Mapp v. Ohio, Terry v. Ohio
- 7. Understand the police use of discretion.
- 8. Explain the exclusionary rule and apply it in mock situations.
- 9. List and explain the exceptions to the hearsay rule.
- 10. List and explain the six exceptions to the search warrant requirement.
- 11. To define probable cause and give examples of when it is present and absent.
- 12. To allow the student to work with a variety of applied techniques.
- 13. Think creatively, make decisions, solve problems, visualize with the minds eye, reason, and how to acquire and apply new knowledge and skills.
- 14. Find, read and explain recent examples of major topics in this course. Examples include plea bargaining, arrests, searches and confessions.
