Course Goals - The goal of this course is to gain an understanding of the production of vodka through the use of various substrates.

Course Format – This is a hybrid course consisting of 25% Internet instruction and 75% classroom. Assignments and reading material will be posted on Grayson’s Internet teaching platform, [Canvas](#), under the “Units/Lessons” tab.

Four, in-class sessions will be held at the T.V. Munson Viticulture and Enology Center, Grayson College – West Extension. Class begins at 9AM and ends at 6PM. The in-class meetings will consist of hands-on activities and lectures/discussions. Attendance to these meetings is required. If you cannot attend please let the instructor know in advance.

Course Requirements and Grading

Quizzes (30%) – Three quizzes will be given over assigned reading material and material presented in class. Questions will consist of multiple choice and short answer.

Exams (40%) – Two exams will be given over the course of the semester. Each exam

will cover material presented on Canvas and at the in-class meetings. Questions will consist of essay, short answer, and multiple choice.

Hands-on Activities (30%) – Four still runs (1 per class meeting will be accomplished. Participation in charging the still, preparing the fruit and making cuts will be performed by each student in attendance.

Attendance –Attendance to the in-class meetings is mandatory. Missing a weekend class will result in a loss of 10% of the final grade.

Financial Aid

Effective July 1, 2000 students receiving Title IV funds (Pell, Federal Grants, and Student Loans), who subsequently withdraw from classes, will be required to return a portion of the federal financial aid received. Drop Rule

Under section 51.907 of the Texas Education Code, "an institution of higher education may not permit a student to drop more than six courses, including any course a transfer student has dropped at another

institution of higher education.” This statute was enacted by the State of Texas in spring 2007 and applies to students who enroll in a public institution of higher education as first-time freshmen in fall 2007 or later. Any course that a student drops is counted toward the six-course limit if (1) the student drops a course after census date or (2) the student is not dropping the course in order to withdraw from the institution. Some exemptions for good cause could allow a student to drop a course without having it counted toward this limit, but it is the responsibility of the student to establish that good cause before the drop. Students with questions should contact the Counseling Office or the Office of Admissions & Records for more information before dropping a course!
